3.3.4 The directives issued by the Board from time to time in view of direction issued by the Honomble High Court of Gujarat in the matter of S.C., A. 770/95 and any other shall have to be complies with.

4.3 There shall be no process emission from manufacturing process & other ancillary operation.

4.4 Ambient air quality within and outside the premises of the unit shall conform National Ambient Air Quality standards notified by MoEF vide notification dated 16/11/2009

and mainly to the following standards: -

- 6.3 In case of failure of pollution control equipments, the production process connected to it shall be stopped. Remedial actions/measures shall be implemented immediately to bring entire situation normal.
- On and monitoring of environmental safeguards and other conditions stipulated by statutory authorities. The Environmental Management Cell/Unit shall directly report to the Chief Executive of the organization and shall work as a focal point for environmental issues. These cells/units also coordinate the exercise of environmental audit and preparation of environmental statements.
